

## **Public Safety**

- Total of 108 cameras
  - 78 been added to existing HBNW network
  - Extensive night time testing of cameras
- All cameras monitored during hours of darkness; perimeter cameras 24/7
- Dedicated Deep Blue response vehicle in SEBCID permanently
  - First port of call for any suspicious incidents
- Monthly contributions to CCP/Watchcon
- Contribution to HBNW commenced

# Val Charlton Landworks Community fire awareness



Europeans governments and citizens alike must rethink their relationship to the landscape or face ever-worsening "They should recognize that it is in their own interest to manage the land in a way that is ... less susceptible to fire," said Johann Goldammer, the founding director of the Global Fire Monitoring Centre at Germany's Max Planck Institute. "If they don't, they will always run after the problem."

"We do not respond to the root of the problem," said Castellnou. "Our society is becoming an urban society."

These trends are strongest in the Mediterranean, but climate change means the higher temperatures that drive them are moving north into central Europe, where uncontrolled wildfires could be even more devastating. Alexander Held, a fire predictions expert with the European Forest Institute, said under these circumstances, central Europe could see "Canadian-style" fires that burn for days and cover thousands of hectares.



While most landholders will happily welcome a fire crew coming to save their forest from encroaching wildfires, controlled burns when there is no apparent danger is a different story.

"It's like a vaccine. A small fire is a vaccine for the biggest fire," Castellnou said. "[And] we are acting like an anti-vaccine society. We don't want the fire to touch our forest."

In a global crisis, no one can escape from every risk or avoid every harm. Rather than trying to neliminate all potential problems, we should prepare to live with them as best we can. "We've been stuck in this mindset that we need to separate ourselves from risk," Clark-Ginsberg said. "In reality, we're products of the natural world. We're products of the human world. These worlds contain risk, and we need to figure out how to navigate that."
